RESOLUTION NO. 23, SERIES OF 2016

A RESOLUTION REGARDING ANNEXATION QUESTIONS AND ISSUES

WHEREAS, the Board of Trustees of the Village of Little Chute find it in the public interest to decree certain understandings so that an owner of lands petitioning for annexation understand their expectations and rights are made clear when annexing to the Village; and

WHEREAS, the Village is not coercing owners or offering special inducement to annex property to the Village.

NOW, THEREFORE, BE IT RESOLVED, by the Village of Little Chute Board of Trustees that the following agreements of understanding are found to be in the public interest;

- 1) Upon adoption of an ordinance annexing the areas described within this resolution the Village will continue to assess agriculturally used/assessed property under Wisconsin Department of Revenue regulated Agricultural use valuation.
- 2) The owners as provided by ordinance will pay connection charges of the Heart of the Valley Metro sewer system when such connections are made for service.
- 3) Owners of property within the area of sewer service shall be required to pay the stand by charge for the sewer interceptors constructed since 1995 when connection is made or at time of subdivision.

BE IT FURTHER RESOLVED, by the Village of Little Chute that petition for referendum or appeal by any party or the Township shall cause all agreements made by this resolution to be delayed until annexation is final and without opportunity for reversal; and

BE IT FURTHER RESOLVED, by the Village that agreements within this resolution shall only be in effect for those annexations submitted and adopted by ordinance within sixty days of adoption of this resolution.

BE IT FINALLY RESOLVED, that this resolution document encompasses all of the agreements, no other agreements discussed verbally or in writing shall be included and are hereby void.
