18.05 Plumbing permits and Fees. (1) WHEN PERMIT IS REQUIRED. (a) No plumbing shall be done in the Village of Little Chute without a permit being first issued therefore by the Building Inspector, and the paying of the proper fee as hereinafter provided. Such permits may be issued only to persons duly licensed to do plumbing under the laws of Wisconsin, provided, any person actually owning and occupying a single-family residence, may do plumbing therein without license and bond, although such person shall secure a permit and work shall fully conform with all requirements as to workmanship, design and materials, and provided further, that any person assisting such owner shall be licensed master plumber. Any plumbing shall conform to all provisions of the state law and codes, and ordinances of the Village of Little Chute

The Applicant, either a Licensed Master Plumber or Property Owner having paid the required fee, \$ _____, evidenced by Treasurer Receipt, is hereby granted authority to do Plumbing Work indicated on the premises and as per application, hereinabove stated, and in full compliance with all Village ordinances and State Plumbing Code, as governing.
