Discussion-Action-Resolution Approving the Project Plan and Establishing the Boundaries for and the Creation of Tax Incremental District No. 5

Phil Cosson of Ehlers and Associates discussed the TID 5 process and the steps that have been taken thus far to approve the Project Plan and boundaries. P. Cosson noted that the Tax Incremental is an industrial district and stated that it meets statutory requirements to be such. P. Cosson discussed the TID Map and its boundaries. P. Discussion/Action – Assessment Policy for Vandenbroek Drainage District

R. Hermus reported that the Village has argued this assessment policy in court to no avail and now the Village must address how to handle fees that are charged to the Village from the drainage district.

R. Hermus recommended that the base assessment from the district be figured into the cost of maintenance for the Storm Water Utility. R. Hermus stated that if any capital projects occur within the drainage district Little Chute residents will be assessed for those charges through the drainage district. R. Hermus went on to say that it would be the responsibility of the drainage district to inform residents of upcoming projects and the reason for the need.

Moved by Trustee Frassetto, seconded by Trustee Hietpas to Approve the Assessment Policy for the Vandenbroek Drainage District as presented.
