Review/Action – Award Bids on Village Hall Technology Upgrades

J. Fenlon reported that RFP's were due today by 2 p.m. at the Village Hall for the technology portion of the Village Hall renovation/addition project and only 1 proposal was received. J. Fenlon stated that two (2) companies that were approached declined to submit a proposal due to the requirements that were outlined in the RFP. J. Fenlon stated that to obtain the technology to meet our needs the RFP outline had to be stringent. J. Fenlon stated that the one (1) proposal that the Village received was from Heartland Business Systems and their pricing is outlined on the IFC that he handed out. Trustee Smith questioned

the price of the audio/visual portion for the boardroom. T. Matheny gave numerous examples of items included in the package. Trustee Joosten questioned if projector screens could be added at a later date to cut down on the cost and T. Matheny stated that the screens are ceiling mounted and that it would not be wise to cut into a new ceiling at a later date. Trustee Frassetto stated that she agreed that the cost is hefty but looking at the big picture it is necessary technology for the future.

Moved by Trustee Frassetto, seconded by Trustee Peerenboom to Award Bid to Heartland Business Systems in the amount of \$148,985.22.

Further Discussion:

Trustee Smith requested a breakdown of everything included in the bid from Heartland Business Systems. Trustee Hietpas stated that it was unusual to receive only one (1) bid for this type of project. J. Fenlon stated that he conferred with Attorney Koehler and it was not necessary to publicly bid this project because it is equipment. J. Fenlon stated that the bid outlined by a consultation to anticipate the Village's technology needs was fairly detailed. J. Fenlon stated that he was expecting to get at least three (3) proposals so he is surprised as well. J. Fenlon stated that the RFP was sent out to four (4) vendors with a coversheet explaining the needs and timeline of the addition/renovation. T. Matheny stated that she purposely approached the security and audio/visual vendors within Little Chute to include a local vendor on a village project.
