Resolutions:

a) Adopting 2014 Village Budget and Establishing the Tax Levy

T. Matheny presented a budget overview and noted that in the next two weeks she will have the final net tax rate for each school district. J. Fenlon noted a onetime \$10,000 allocation for the Little Chute Library book collection which will be held until after the renovation/addition is complete in case the money is needed to pay for any cost overruns.

b) West Evergreen Drive Maintenance

R. Van Gheem stated that the Ordinance passed earlier designates West Evergreen Drive as a truck route and that it passes through 3 municipalities (Little Chute, Grand Chute, and Town of Vandenbroek). R. Van Gheem went on to say that Little Chute has maintained this road since 2005. R. Van Gheem stated that portions of West Evergreen are in the Village's Capital Improvement Plan due to development of the area. R. Van Gheem stated that due to utilities being installed in 2005 the road was destroyed and that is why the Village paid to have the road reconstructed. J. Moes stated that in creating TID #4 the Village included in the project plan to assess residents and also use the TID increment for the areas that cannot be assessed. J. Moes went on to say that the portions that were not assessed are held in abeyance until the time of annexation. Trustee Hietpas questioned the percentage of the road that is in Little Chute and R. Van Gheem stated 50%. Trustee Frassetto stated that she is disappointed in the lack of cost sharing by the other communities.

Moved by Trustee Frassetto, seconded by Trustee Smith to Adopt Resolution No. 43, Series of 2013 Accepting Responsibility for Normal Maintenance of West Evergreen Drive.

Department and Officers Progress Reports

FVMPD - no report. Teri Matheny report: thanked board members and staff for their efforts during the budget process; bills for the addition have started coming in and noted that the first installment of the donation has been pulled from the donors account; department completed the upload to the county site for the tax roll so as soon as she has final numbers she can have the tax bills printed; Village Hall is experiencing problems with the phone system; James Fenlon report: Emergency Assistance is now available from the August storms through the Outagamie County Community Development Block Grant; working on development projects that should come before the Board soon; has asked Larry Burkhart from the Fox Cities Regional Planning Committee to do a presentation for the Board in January of 2014; met with Al Ott this week and Mr. Ott has offered his support if needed in the future; met with a furnishings

company this week for potential needs in the Village Hall addition; met with the Fox Cities Convention and Visitors Bureau and will become a representative for the Village; applied for a grant for an information kiosk to be placed in the lobby of the new addition; staff evaluations are almost complete and will give the board an overview in late December. James Moes report: meeting with attorneys regarding the Walgreens tax case. Tom Flick report: Park Planning will be getting the final bidding and designs for the Doyle Park Shelter; Board members will be seeing some easements for approval from the Fox River Navigational System Authority for ingress/egress electrical easements; discussed trail counter at Heesakker Park and noted that the average daily count is 75 people; DNR has recently released a presentation regarding the Emerald Ash Borer and noted that he will present this to the Board at a later date; deer culling in Heesakker Park will begin on December 2, 2013 and noted the closure of the park; Enterprise Electric has volunteered their time and materials to hookup the new slide at Doyle Park and asked board members to thank owners for their kindness. Roy Van Gheem report: department is making a last pass at picking up leaves; department has been successful at closing some utility projects this year and hopes to finish up a couple more; working with the DOT to close out the Main Street project; trying to acquire grants for upcoming projects in the Village. Sandy Berkers report: Newsletter articles are due to Vicki by December 2, 2013. Attorney Koehler no report.
