Discussion/Possible Action—2014 CTH N Update

Andy Rowell, Highway Engineer with Outagamie County presented an overview of 2014 project County Hwy N. He performed a traffic and pedestrian safety review at the intersection of County Trunk Highway N and Greenfield Drive. This included review of intersection sight distance, stopping sight distance, and observations of vehicles and pedestrians. The speed limit on CTH N is 25 mph. The intersection is directly across from the Little Chute High School front building entrance. He observed the crossing during an afternoon dismissal. Overall there were 40 total student pedestrians that crossed near the intersection between 2:50 and 3:30 p.m. 11 of these were students riding a bike across. 28 out of 40 were observed to cross outside of the crosswalk, with many crossing at the north side of the school driveway and crossing diagonally towards the Greenfield Drive north sidewalk. Most motorists were observant of pedestrians as they approached the crossing. Pedestrians crossing from the school grounds to the west have good sight both north and south of the intersection. However, for students crossing east towards school, the same sight distance problems exist for cars making the left turn from Greenfield Drive. This is a real safety concern where a pedestrian cannot be seen until the vehicle is at or below the minimum stopping sight difference. Under the existing highway conditions, he recommended against signing the intersection as a school pedestrian crossing. The school district is encouraged to inform its students to cross CTH N at CTH OO or Florida Avenue.

Moved by Trustee Smith, seconded by Trustee Van Lankvelt to eliminate the crosswalk at Greenfield and add additional signage.


