Public Appearance for Items Not on the Agenda

Mr. Stouffer spoke on motions to reconsider and that it has restrictions on it. The only person that can offer the motion is someone who voted with the prevailing side are there are timelines. He read the rules on how to rescind motions and how to amend a motion that was previously adopted.

Administrator Fenlon would like the Board to consider Item G (Discussion of Bike Lanes) prior to Item F (Striping of Riverside Dr) as Item G may answer some of the question for Item F.

Discussion—Bike Lanes

Administrator Fenlon stated letters were sent to residents to discuss bike lanes and that he sent the Board of Trustees some documents and comments on Riverside Drive for paving. This discussion really centered around removing bike lanes from the assessment policy and in particular this year's projects. Trustee Van Lankvelt said he had parking eliminated and he was initially upset but it hasn't been an issue. Trustee Joosten stated he prefers a bike route not a bike lane. President Vanden Berg stated that several concepts were presented to the board and the concept the board went with was bike lanes. We keep having the same discussion every week on this and nothing changes. We sit here on the eve of pouring concrete and we are still talking about bike lanes. This body was elected to make decisions. There was a plan; we need to follow that plan. Sometimes we disagree but at the end of the day we walk out of here and decision needs to be made. Chris Berkers from 2209 Riverside Drive stated his concern is there was a policy for bike lanes in 2009 and we are strictly trying to adhere to this policy and it doesn't seem to be fitting. People that will use the bike lanes have no interest in biking in the village, they want to bike out in the country. Trustee Smith stated he knows the Board had talked about getting out into the community more and it would be nice to have neighborhood meetings.

Discussion/Action—Striping of Riverside Drive

Administrator Fenlon presented the Power Point slides that were shown in May of 2014 regarding the striping of Riverside Drive. Trustee Van Lankvelt stated it's not good policy to change or rescind a motion after a project has started but thinks it would be in our best interest not to paint those lines for the bike lanes until a later date. He stated it would be more consistent if we voted bike lanes out of Lincoln Ave and continue with bike routes on Riverside. Trustee Van Lankvelt stated he doesn't understand why we cannot eliminate the lines for now and see what happens. He would like to eliminate the paint for now. Trustee Smith stated that we need to make a decision tonight on this and what we are going to do with it because we are not going to have people come back to add the stripes. We need to make up our mind. Trustee Elrick added a decision needs to be made and in his opinion it was already made. It was made a number of times so leave the decision as it is. President Vanden Berg stated that Riverside is a great area for bike lanes and he sees a lot of cyclists there. We made this decision several times and the board was fully aware of the design and consequences of the design with parking. In the end, it will be a showcase street. In my opinion to not put the striping down would leave it a mess. We should proceed as we voted originally. Trustee Hieptas stated he is in favor of not putting striping down and he wants to see it be used as a bike route not a bike lane. Trustee Joosten stated he is in favor of a bike route. Trustee Elrick asked what action do we take if we leave the project as is? President Vanden Berg answered the only action would be if someone makes a motion to take the striping off.

Trustee Joosten made a motion that we do not stripe Riverside Drive, seconded by Trustee Hietpas


