There is temporary bridge that spans the section that they will be working in. FRSNA hired a contractor to fix the walls and the temporary bridge will be removed in April 2015. The existing agreement with HOV has expired with Janke and currently we do not have vehicular access to Island Park except through Heesaker Park and along the Heritage Parkway trail. The project is at the Federal Highway Bureau and is going through for review.

Administrator Fenlon reported briefly on this topic but based upon the previous item the board agreed to lease a bridge from Janke for \$500 a month until May.


