Discussion/Action—McKinley Street/Grand Avenue Reconstruction

Director Van Gheem reintroduced this project a couple weeks ago. As a reminder, this project was slated for several years ago but due to outside forces it was placed on hold. It has been slated again for 2015. The project shown was the selected layout from 2009. Since that time, a few things have changed. The Village of Little Chute received a grant to supplement the cost but along with that grant comes new requirements. Our goal tonight is to show you what implications the grant money has on this project. We need to meet complete streets or we will have to apply for exceptions. Complete streets involves sidewalks and bike lanes. Trustee Van Lankvelt asked Director Van Gheem to explain to Trans 75 requirements and what its implications are. Trans 75 is legislation that was put into place over 6 years ago which requires projects funded by state and federal must meet certain requirements. Those requirements include walking, bikes and automobiles. There is a set of standards and criteria the Village has to meet and one of them is for there to be bike lanes and sidewalks on both sides of the road. Mike Simon with McMahon and Associates presented slides on six basic options. After the presentation, Director Van Gheem stated we are trying to find the best way to accommodate the school and the residents. We are trying to figure out the best option while acknowledging that none of them are perfect or great for everyone but rather what option will serve the most people, the Village and the school. It will not meet everyone's needs or wants but we will do the best that we can. Most of the comments from the residents that attended this meeting was everyone was all for more parking, including the possibility of a parking lot. They do not want to lose their terraces nor are they interested in one way street. The Board directed staff to contact the property owner and report back meanwhile also directing the staff to work with WIS DOT on receiving exceptions to 75 requirements.

Action/Approval—2015 Kaukauna Utilities Billing Agreement

Director Matheny presented an annual agreement that has been in place with Kaukauna Utilities since 1995. She indicated the changes and there has been a consistent increase that we've experienced in previous years. What is driving our increase is we have added 157 new customers that have been approved by the Water Commission.




