Discussion—LCFD Aerial Ladder

Fire Chief Jansen and his team presented the Aerial Discussion Matrix dated July 20, 2016. The Options are: 1. Purchase New Aerial 2. Lease New Aerial 3. Refurbish Current Aerial 4. Purchase Used Aerial 5. Status Quo of No Aerial into Future. Options 1 and 2 are the recommended options and the costs are between \$819,387 and \$973,767. There was discussion on the best way to pay for this item whether it be leasing or adding the item to the tax roll. There was also discussion on finding a demo model that can be leased. There are approximately 50 volunteer firefighters and their safety is of utmost importance. This topic will be revisited at an August Board meeting.

Discussion/Action—McKinley/Grand Lighting

Administrator Fenlon talked with Mr. Botz from the LCASD and it was agreed that the cost of the nine new lights will be split between the Village and the School District.


