Discussion—Presentation on G.O. Debt with Ehlers and Associates

Phil Cosson went over the Preliminary Five Year Capital Plan dated August 10, 2016. He went over existing debt and noted that debt coming on is replacing debt going off. Little Chute has more growth than the state average. He went over the base case and where the village is at if they don't do any capital borrowing. The full range of capital projects was also shown.

Discussion/Action—Municipal Services Building Site and Schematic Design

Administrator Fenlon gave a background of the Municipal Services Building project. The design was developed with staff input and field trips to other community's public works buildings. A working group was formed and came up with the original site plan. Jon Wallenkamp went over the site layout. There was no concern regarding the proposed site. There was discussion on whether to implement Schematic Design Option A, B or C. Jon and his staff recommend precast walls with a steel frame.

Discussion/Action—Municipal Services Building Construction Schedule

Jon Wallenkamp went over the two potential Project Schedules. The village is currently leasing for the temporary public works site and the lease is up in August 2017. There is no certainty on future lease costs at this time. Trustee Elrick is concerned that Option #1 will not allow enough time and he is also wondering if waiting until January 1, 2017, when prevailing wage goes away, it will open up the potential for more bidders.




