Discussion—2017 Budget

Director Matheny presented an overview of Expenditure Restraints and Utilities. Director Matheny also talked about the utilities and the need for updating the strength ordinance and the possible implementation of a pretreatment monitoring system for businesses. Director Elrick talked about ammonia being on the rise and how it cost the village \$27,000 in November compared with \$16,000 in January.

Discussion—Madison Street Village Owned Property

Director Moes stated that there is some renewed interest in this property. The asbestos has been removed. The gas lines have been removed and the electricity still remains. There is a public auction set for December 3, 2016. Administrator Fenlon noted that either the home will be removed or demolished in spring. If it ends up being demolished, it could possibly be used for fire training.

Discussion—Well #1 Update

Administrator Fenlon talked about this in his Progress Report. The bid opening for Well #1 is taking place on December 1, 2016 at 10:00 a.m. Mobilization will happen in February or March of 2017. Construction will take place in May 2017 and needs to be completed by June 30, 2017.
