Public Hearing—2000 Taylor Conditional Use Request

Moved by Commissioner Moes, seconded by Commissioner Van Lankvelt to enter into closed session

Director Kittle went over the request for a conditional use permit at 2000 Taylor Street for a bussing company to use part of the lot for the parking of 10 busses. Mr. Tim Mitchell, N9607 Golden Way, and another neighbor expressed concerns for the increase in traffic of busses going in and out will affect air quality.


