Department and Officers Progress Reports

Chief Peterson reported on the procedures the Department is using to handle pickup and holding of stray dogs and cats. D. Haug reported that the Disbursement List includes tax payments to other taxing agencies. D Haug stated staff is beginning preliminary planning for the 2006 audit and that W2 forms had been distributed. C. Kell reported on the quality issue with the community video linked to the Village's website and also updated the Board on the status of contracting with a company to update the Village's website. C Kell stated that he will be sending a letter to the Fox Locks Authority asking them to delay work on the Little Chute locks until 2008 to give the Village time to deal with the issues of the bridge and park land. C. Kell reported that the traffic data report on the area of Hwy. 00 and French Road has been completed and after it is reviewed by the parties involved it will be reported to the Board. J. Moes reported that an annexation petition of 59 acres to the north of the Village is being circulated and the petitioner has published the official notice. The signed petition will go before the Plan Commission for review and recommendation and then it will be presented to the Village Board. T. Flick gave an update on the terrace tree trimming program and stated that Department is currently taking applications for summer help and bids for the pool filter replacement are due on Friday. T. Flick also stated the rinks at Heesakker Park will be flooded by the end of the week. R. Van Gheem reported on the status of the French pond project and stated that the bid opening for 2007 projects will be held on January 25th. R. Van Gheem also clarified for the Board that the for the first few

years the entire area except for the safety shelf of the Buchanan Street pond will be mowed to keep the weeds down so the prairie grass can be established. V. Karch stated that over 200 people will be in attendance at the Recognition Dinner and that staff is currently meeting with representatives from companies who have submitted quotes for updating the Village Code. Attorney Koehler reported that he is working with the Public Works Director to come up with a plan to permit televising of sewer laterals.
