Welcome to the 2015 Fox Valley Metro Police Department's annual report. This edition of our report brings some changes that you will see on the following pages.

We have added five pages showing overall trends in certain crimes for a span going back to 2010, how we ended the year in terms of monthly measures and finally statistics on searches and use of force in 2015. This information will be a regular part of our report going forward and an example of how we intend to increase the level and quality of information that we send out to elected officials and the community.

A couple of comments on the statistics:

- Overall, the crime trends in our villages are generally reflective of overall trends across the country.
  - A slow but steady decrease in overall crime since 2010 with a slight up-tick in 2015, particularly in criminal referrals (more serious crimes).
  - In short, slight decreases in the OVERALL numbers but slight increases in more serious crimes.
- As noted, the decreases noticed in 2013 are reflected by some missing data in the early part of the year due to a software change in the system. It would be a fair assumption that there was actually only a slight change between 2012 and 2014, following the overall trend line.
- Finally, while percentages are noted in the statistics, keep in mind that many of the categories entail relatively small numbers to begin with; therefore, even small changes in the numbers may reflect a fairly large percentage swing but are actually not significant.

The bottom line is that our Villages remain very safe places to live with a high quality of life.

## **A look forward to 2016...**

In order to do our part to ensure these high standards of safety and quality of life continue into the future, I believe that it is important to continually look for ways to improve our service and be open to new ideas.

In response to numerous critical incidents and the resulting strained relations between police nationally and the communities they serve, President Obama commissioned a Task Force made up of law enforcement and community leaders to bring everyone together and get ideas on how to improve relations between the police and their communities. Named the President's Task Force on 21<sup>st</sup> Century Policing, the task force completed and released its final report in 2015.

The report contains numerous recommendations associated with six “pillars” (themes) for police departments and their communities to adopt and incorporate into their operations.

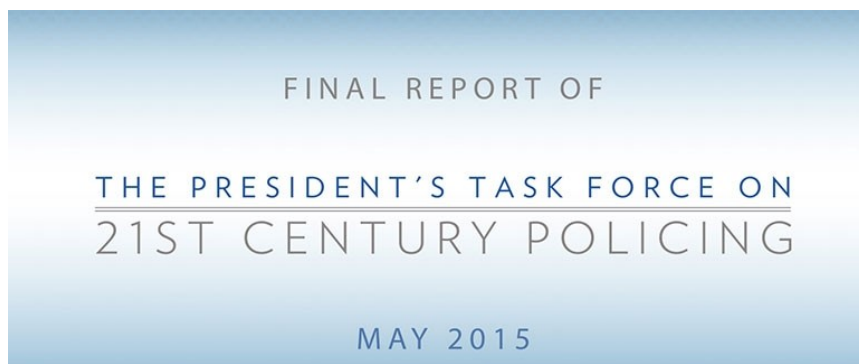
Those pillars are:

- 1. Building trust and legitimacy**
- 2. Policy and oversight**
- 3. Technology and social media**
- 4. Community policing and crime reduction**
- 5. Training and education**
- 6. Officer wellness and safety**

As a leader who believes that there are always things that we can do better as individuals and organizations, I decided to not only read the Task Force report but to introduce it to the department and work on implementing the recommendations that make sense for us and our communities. I am happy to say that we, as an organization, are already ahead of the curve in many areas of the six pillars.

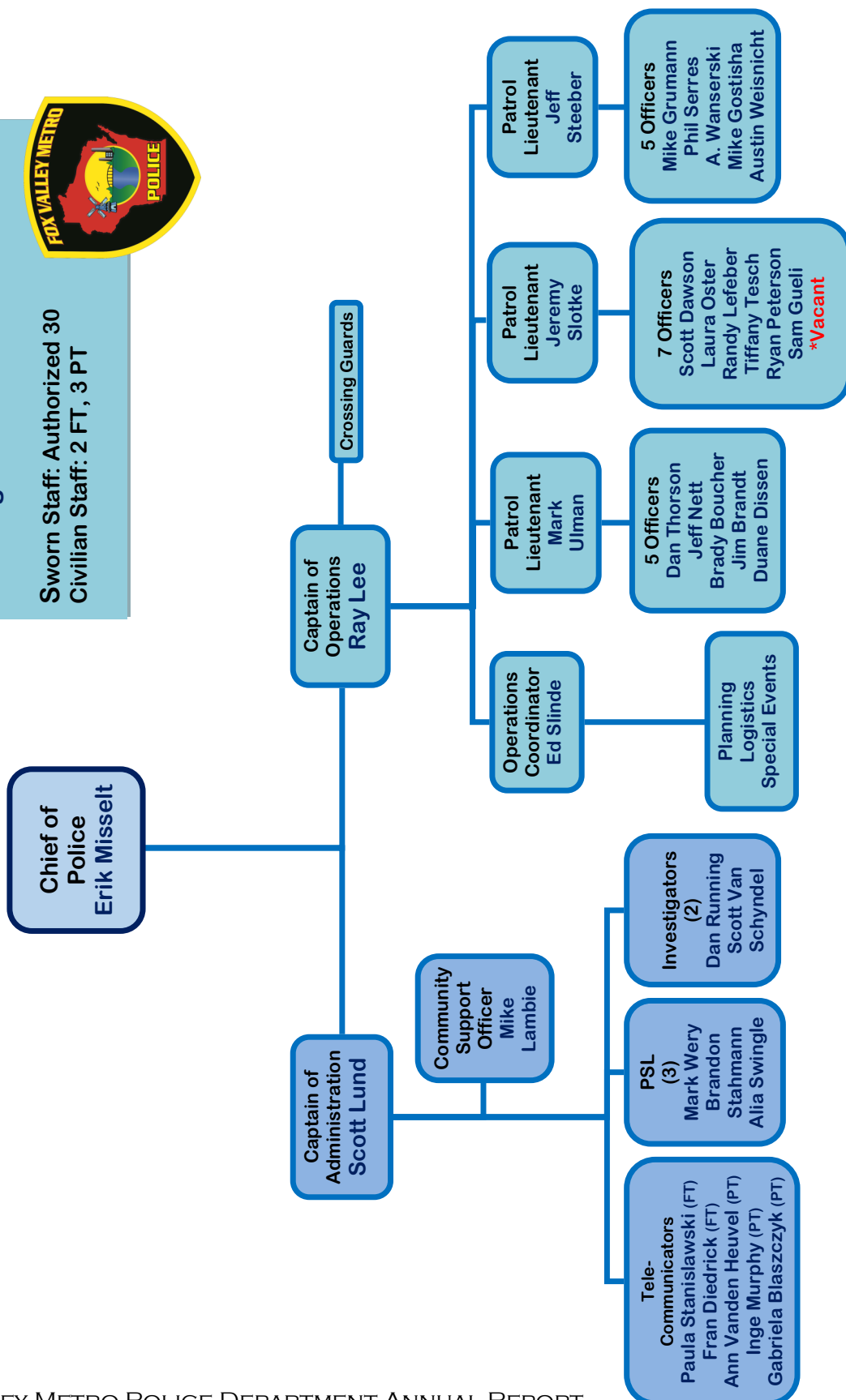




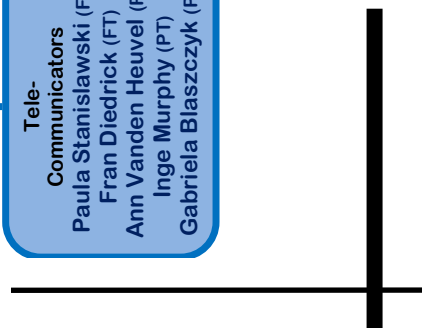
## Fox Valley Metro Police Department Organizational Chart 2016

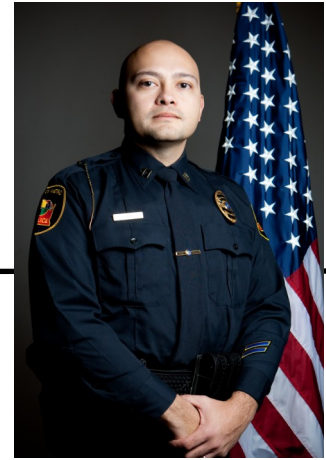

**Captain Lee**

Administrative Services is led by Captain Raymond Lee who oversees several aspects of department operations including:

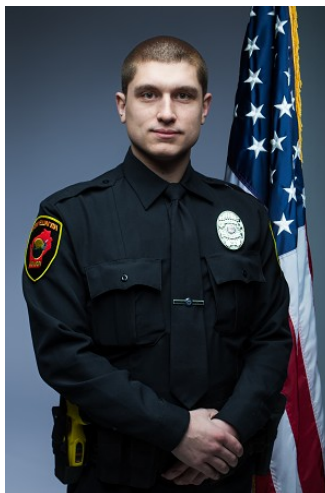
- Investigative Services
- Police School Liaison Program
- Records and Telecommunications
- Hiring and Recruitment
- Community Support
- Court Services
- Training
- Uniform Crime Reporting

Administrative Services is staffed by two investigators, three police school liaison officers (PSL), one community support officer, two full-time and three part-time civilian administrative staff.

Officers assigned to the Investigations Section conducted several major case investigations involving an attempted homicide, two heroin related over-dose deaths, and numerous drug related and child maltreatment investigations.

The expertise of the Investigations Section was recognized on several occasions with Fox Valley Metro Police Department officers providing testimony to the State Legislature on child maltreatment legislation, invitations to present at regional conferences on prostitution and human trafficking, and involvement on several multi-disciplinary committees.

As always, Fox Valley Metro Police Department continued understaffed, and while a hiring process was conducted in the second quarter of the year, culminating in the hiring of Officer Samuel Gueli, by year-end the department will remain under-strength.

### **Investigations**

The Investigations Unit is under the direct supervision of the Captain of Administration. Currently, there are two officers assigned to Investigations. In addition to handling all major investigations and assisting patrol with more complex assignments, the Investigations Unit is responsible for the management, control and disposition of property that is found, recovered or seized by the Fox Valley Metro Police Department.

The Investigations Unit has been responsible for handling open records requests for video and photographic evidence made by the general public, the District Attorney's Office and defense attorneys. Late in 2015, some of these duties were turned over to civilian staff with Investigations still assisting as needed.

There were numerous large cases that the Investigations Unit assisted in or investigated in 2015. These included an attempted homicide, residential and business burglaries, sexual assaults, physical assaults, armed robbery, major thefts, and several death investigations including suicide and other death scenes where the deaths were not by natural causes.

The Fox Valley area has seen a dramatic increase in drug overdoses, particularly by heroin and methamphetamine users. The Investigations Unit investigated two heroin overdose deaths in 2015. The Investigations Unit also served several drug warrants on homes and apartments and assisted the Lake Winnebago Area MEG Drug Enforcement Unit in several other warrants.

One of the investigators in the Investigations Unit attended training at the Force Science Institute in Chicago. The Force Science Institute studies use of force incidents involving law enforcement officers and are considered experts in this field when it comes to determining if the officer's actions were justified. This training is crucial in a time when any use of force by law enforcement is questioned. The investigator that received this training will be the liaison between the Fox Valley Metro Police Department and the outside agency asked to investigate a deadly use of force incident involving a Fox Valley Metro Police Department Officer.

An investigator was fully trained in the use of a Universal Forensic Analysis Device (UFED). The UFED is used to analyze digital evidence from electronic devices. This has assisted in multiple Investigations, and its use continues to grow. Another investigator will be getting fully trained on the UFED in 2016. Due to the cost of the UFED, it is shared with multiple other agencies all of which can also utilize this great piece of technology.

### Community Support

The Community Support Officer position, which is currently held by Michael Lambie, is responsible for coordinating the department's crime prevention strategies including Neighborhood Watch and Chronic Nuisance Abatement Program. The Community Support Officer is also the point-of-contact for citizens and serves as the department's liaison for outside agencies such as Quad Cities Crime Stoppers, Victim Crisis Response Team, Sex Offender Registry and media outlets. Fox Valley Metro Police Department social media accounts are also managed by the Community Support position.

### Police School Liaison Program

The Fox Valley Metro Police Department's Police School Liaison (PSL) Program serves to collaborate with the Kimberly and Little Chute School Districts, Outagamie and Calumet County Human Services, and other community organizations to provide a safe and secure environment for the students of our communities. In addition to this, our PSL officers serve as the main investigators of sensitive crimes against children.

The Fox Valley Metro Police Department staffs three PSL officer positions. Officer Stahmann and Officer Wery work with the Kimberly Area School District, and Officer Swingle works with the Little Chute Area School District. In addition to the work performed in the public schools, these officers also work with the parochial schools on an as-needed basis.

Some of the job responsibilities of the Fox Valley Metro Police Department PSL officers include:

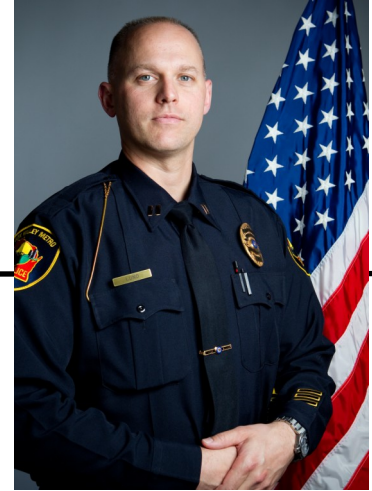
- ♦ Promote prevention through education and communication
- ♦ Classroom presentations (bicycle safety, Halloween safety, bullying/harassment etc.)
- ♦ Constitutional Law Education
- ♦ Drugs and alcohol enforcement
- ♦ Educating students on law enforcement's role in the community
- ♦ Facilitating the Juvenile Police Academy

The primary goals of the Fox Valley Metro Police Department PSL Program is to foster positive relationships with the students and their families. By forming these relationships, the PSL officer builds trust and credibility which allows them to work closely with students and their families to help solve issues and concerns. This helps students to see the PSL officer as more approachable and someone who strives for their well-being. Students are more comfortable coming to the PSL officer and reporting illegal activity and things that make them feel unsafe. This makes the school environment safer for all.


As a team, the day shift focuses on quality of life concerns and working with citizens to make the community safer. Each member of the day shift is the lead officer in their Community Oriented Policing (COP) District. Officer Thorson worked with members of his COP District and Fox Valley Metro Police Department Investigators to identify and shut down a house that was using and dealing heroin.

Day shift officers also routinely worked in conjunction with the Department's Investigations Unit. They assisted with the abatement process, the service of search warrants, and the investigation of several complex and multi-jurisdictional cases. Officer Brandt was able to apprehend multiple suspects in a complex investigation of one of the bars in our jurisdiction. Officer Nett worked a theft complaint, which turned into a home search, that solved theft and stolen credit card complaints from multiple jurisdictions.

Additionally, the day shift officers have focused their efforts on numerous community oriented and crime prevention efforts:

- ✧ Performing physical security checks on businesses in the industrial parks and downtown
- ✧ Being present at local banks and credit unions when employees are arriving to open
- ✧ Performing physical security checks on the homes of residents who were on vacation
- ✧ Performing additional patrols in specific locations based on extra patrol requests from citizens
- ✧ Performing foot patrols in parks, the YMCA, and locations where children are known to congregate
- ✧ Being visible and performing traffic enforcement in school zones while children are heading to school

Members of the day shift also serve roles as Emergency Response Team (ERT) members, Field Training Officers, and Honor Guard members.

During the 2015 calendar year, in addition to their daily responsibilities, including responding to calls for service, and performing traffic and ordinance enforcement activities, officers from the afternoon shift focused on quality of life issues in the villages. The officers maintain close contact with the citizens so that our department is aware of their concerns. Officers spent just over 300 man hours on abatement issues, maintaining regular contact with the neighborhood watch groups, and on other community policing activities.

- ⇒ 613 Oster: Point person for abatement properties and COP / POP Chairperson
- ⇒ 615 Boucher: Youth soccer coach, assistant Boy Scout leader/mentor, researches and provides the “Crime Prevention Tip of the Month” for the department’s Facebook page, working with CN Railroad to improve safety for Little Chute students going to and from school
- ⇒ 617 Weisnicht: US Army Reserve 12-month deployment to Guantanamo Bay, Cuba returned to patrol duties in October 2015
- ⇒ 618 Dissen: Conducts annual pop tab collections at Janssen and Westside Elementary Schools, in 2015, 355 pounds were collected resulting in a \$268 donation to the Ronald McDonald House Charity, represented Fox Valley Metro Police Department at a high school career fair
- ⇒ 626 Tripoli: Maintained department SharePoint program, resigned after one year to pursue his Master’s Degree
- ⇒ 633 Lefebber: Department radar instructor, assists operations in maintaining Badger Tracs (State electronic citation program), MACH (DOT interface), DPW liaison for signage

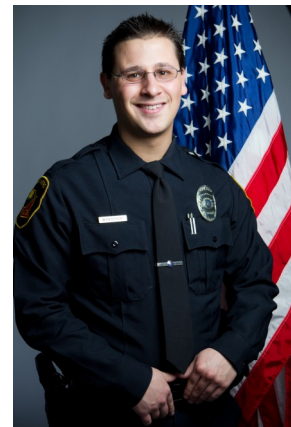
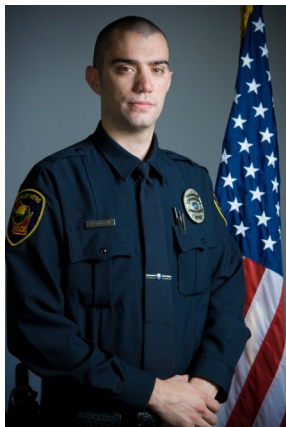

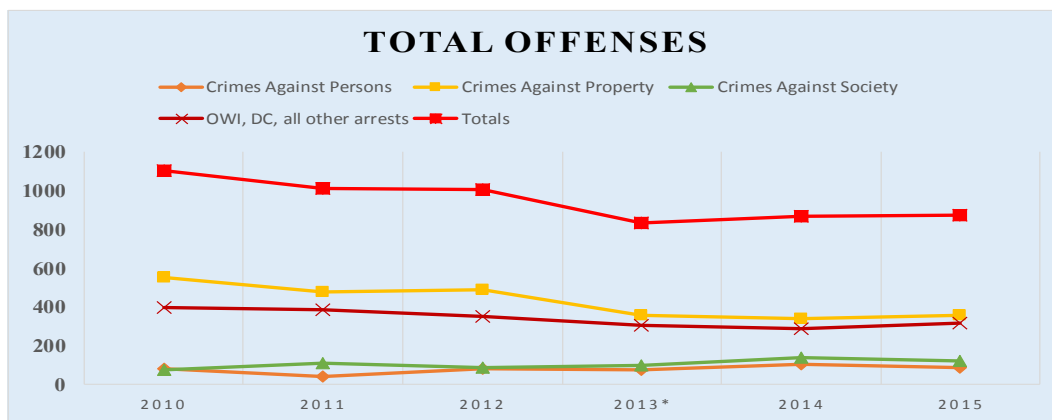
The following are some notable self-initiated field activities some of the night shift officers were part of this year:

- ◇ On March, 26<sup>th</sup>, 2015, Officer Philip Serres conducted a traffic stop on a vehicle on the Community Bridge. Suspicious with the driver's behavior and drug history, Officer Serres proactively attempted to gain consent to search the driver's vehicle. While speaking with the driver outside the vehicle, Officer Serres observed the driver dropped a baggy, of what turned out to be methamphetamine, from his pant's pocket. A search of his vehicle revealed 95 grams of methamphetamine. The driver, due to his history, was charged in U.S. District Court and was sentenced to five years in prison.
- ◇ On August 8<sup>th</sup>, 2015, Officer Aaron Wanserski observed a large amount of juveniles coming from a house in Combined Locks. Suspicious there may be an underage alcohol party at the residence, Officer Wanserski and other officers made contact at the house and were allowed inside discovering a very large amount of juveniles, as well as some damaged property in the home. It was discovered that the homeowner's son hosted the party without their knowledge. Thirty-nine municipal summonses were issued for underage alcohol. The homeowners were very appreciative as Officer Wanserski prevented further destruction of their property.
- ◇ On August 27<sup>th</sup>, 2015, Officer Ryan Peterson, while off-duty in the City of Appleton, observed a man lying down in a parking lot. Officer Peterson, though off duty, quickly ran to the man's aid and found he was not breathing and did not have a pulse. Officer Peterson and another citizen began CPR on the man until Gold Cross Paramedics arrived. Officer Peterson's actions led to the man's survival which likely would not have occurred without Officer Peterson's quick response and dedication.

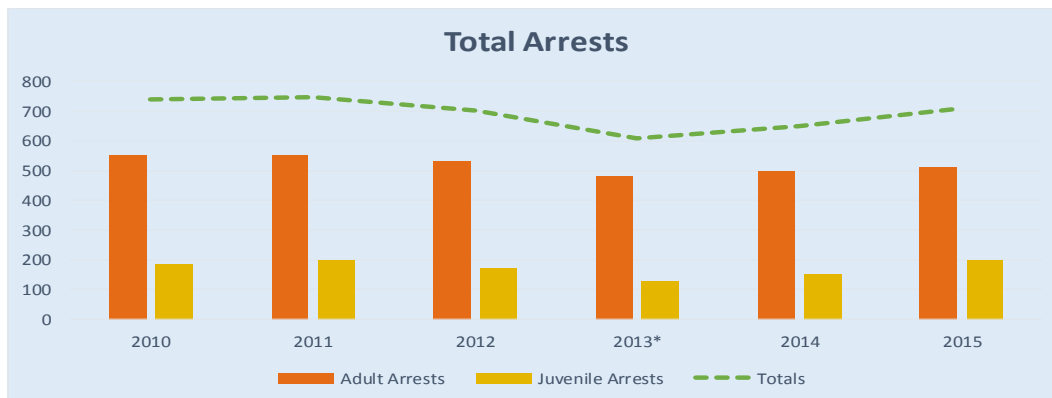

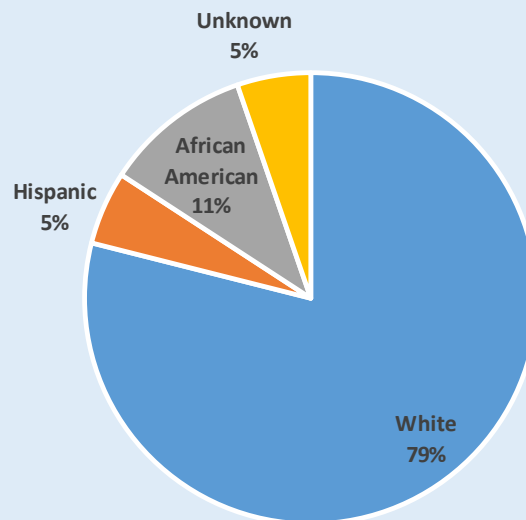

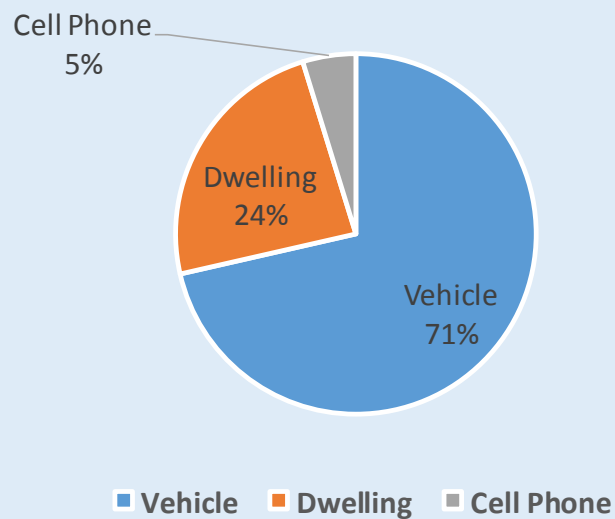

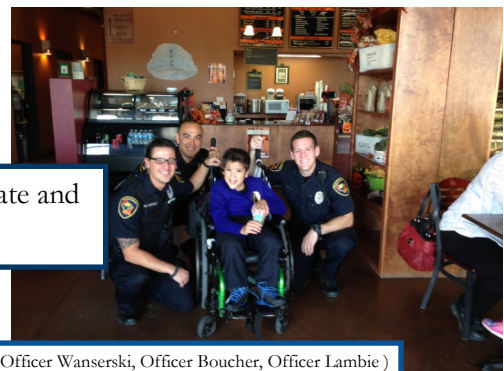
