**The Little Chute Fire Department (LCFD) is an all volunteer fire department which serves the Village of Little Chute. The department currently consists of 44 members, which consist of 1 Chief, 3 Assistant Chiefs, 2 Captains, 4 Lieutenants and 34 firefighters, we also have a retired Fire Chief who serves as our fire inspector. We meet every Monday (which you are required to attend as many as possible) we also have opportunities for additional training through different sources. In 2019 we responded to 202 calls for assistance (Structure fires, extrication, accident cleanups, and alarms sounding) we currently do not respond to medical calls as we are strictly a fire department. As a member we ask that you make as many of the calls as possible but do realize that family & occupation are a priority.**

**We are truly considered volunteers in the sense of that we receive \$2.00 per call and weekly training. Our department is considered one of the finest in the State of Wisconsin, and our Village provides us with state-of-the-art equipment.
