## REGULATIONS

---

- ☐ Keeping of chickens is only allowed on properties zoned RC Conventional Single Family or RD Dense Modern Single Family.
- ☐ Not allowed on vacant properties.
- ☐ No roosters are permitted.
- ☐ Maximum of 6 chickens.
- ☐ Chickens must be kept within the fully enclosed coop and/or run at all times.
- ☐ Must provide proof of registration with the Wisconsin Department of Agriculture, Trade, and Consumer Protection pursuant to Wis. Stats. § 95.51 and Wis. Administrative Code ATCP 17

### Chicken Coop & Run Requirements:

- ☐ Must be located in the rear yard.
- ☐ The maximum height of the coop is 8 feet.
- ☐ Minimum setback of 10' from all property lines and minimum of 25' from all homes on adjacent properties.
- ☐ Must provide a minimum of 3 square feet of coop floor area per chicken. Maximum size of 64 square feet.
- ☐ All coops must include an attached, enclosed run area.
- ☐ Coops and runs must be clean, well maintained and securely protect chickens from predators and weather
- ☐ Coop and run must be stationary.

## INSPECTION REQUIRED

Upon completion of the chicken coop and run, the applicant must contact the Building Inspector to schedule a final inspection. The license will not be issued until the Village has inspected the property and confirmed a compliant chicken coop and chicken run have been provided.
